

Erosion & Sedimentation Pollution Control Plan Review

Fee Schedule

The following fees will be charged by the Union County Conservation District for Erosion and Sediment Pollution Control Plan reviews as authorized by Act 217 – The Conservation District Law. Applications will not be accepted for review without the appropriate fee, completed application form and required plan. This fee schedule will become effective January 1, 2006.

RESIDENTIAL/COMMERCIAL AND ALL OTHER EARTHMOVING ACTIVITIES:

1-1.99	\$100
2-2.99	\$125
3-4.99	\$150
5-6.99	\$175
7-8.99	\$200
9-10.99	\$225
11+	\$25/acre

*Project Area is the acreage covered by the E&S plan.

**This fee does not include any other fees such as NPDES.

Procedures:

1. This fee schedule shall apply to those plans that are submitted to the Union County Conservation District (UCCD) requesting determination of Erosion & Sedimentation plan control adequacy.
2. All applications that require NPDES permits must submit two checks: One for review/approval of the E&SPC plan made payable to the Union County Conservation District, the other for NPDES permit application made payable to UCCD/Clean Water Fund.
3. Each submission of a different project on the same tract of land will be charged according to the fee schedule.
4. Agricultural plowing and tilling is exempt from the fee schedule.
5. Fees will be waived for an application filed under the name of the Commonwealth of Pennsylvania or a governmental subunit of the same.

National Pollution Discharge Elimination System (NPDES)

1. The Commonwealth of Pennsylvania through mandate from Federal Law now requires a fee for construction activities based on the disturbed acreage of a project. These fees are based on the following criteria:

<u>NPDES Permit Criteria</u>	<u>Permit Required</u>	<u>Fee</u>
1-4.99 acres with a point source discharge	NPDES Phase II General Permit	\$250
5 acres and over	NPDES General Permit	\$250
Projects in High Quality or Exceptional Value watersheds, or if the project will discharge toxins	NPDES Individual permit	\$500
