Hours & Location for Collecting 2022 School Tax Bills
MIFFLINBURG AREA SCHOOL DISTRICT

The district is extending the discount period for ALL taxpayers to September 30th.

The district has been made aware of a second issue regarding the real estate tax bills. Tax bills mailed with an address designation of North (N), South (S), East (E) and West (W) were addressed incorrectly. For example, E. Chestnut was printed Chestnute and E. Market was printed Markete. This means that many tax bills were not delivered due to not having a street by that name, it could have been delivered to an incorrect property, they could be sitting in a postal hub in limbo or quite possibly they could have been delivered. As we now have been made aware of this issue and investigated what occurred, we feel it necessary to resend the tax bills for these properties affected. It is anticipated that the corrected bills will be mailed within 2 weeks. Please note that there is a chance that a duplicate bill may be received.

Hartleton Borough, Hartley Township, Mifflinburg Borough, New Berlin Borough, and West Buffalo Township Residents

We are working with Berkheimer to identify those taxpayers in which the bills remain unpaid, to have the bill reprinted and mailed to the correct address.

The District has been notified by the Union County Assessment Office that there is an error with the Clean & Green Exemption Calculation on the 2022 Real Estate Tax Bills. The County is in the process of correcting this error and new real estate bills will be mailed to those taxpayers with a Clean and Green Exemption. If you are a taxpayer that has a Clean & Green Exemption, we suggest that you wait to pay your tax bill until you receive the corrected bill. It is anticipated that the corrected bills will be mailed during the week of July 18.
